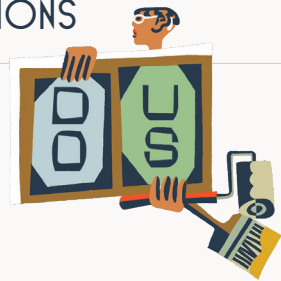

What is the deposit structure?

- 20% → At Contract Signing
- 10% → At Groundbreaking
- 10% → At Topping Off
- 60% → At Closing

What sets the location of DUOS apart?

DUOS is ideally positioned in the heart of Wynwood, just one block from 2nd Avenue—the neighborhood’s central corridor for leading offices, retail, dining, galleries, and nightlife. This proximity offers immediate access to the energy and convenience of the district, while its slightly removed setting provides a more refined and relaxing hospitality experience.

What amenities does DUOS offer?

The building was intentionally designed for short-term living, with amenities tailored to the needs of transient guests while thoughtfully avoiding features that carry excessive long-term operating costs for owners. Its location further enhances the offering, placing residents just steps from one of the most amenity-rich neighborhoods in the country.

Who is the Condominium Association (HOA) management company?

The HOA will be managed by a community association management company with experience in Florida condominiums. It is anticipated that the Association will engage FirstService Residential, a licensed firm that manages over 12,000 units across the United States.

In addition, the Association plans to retain a hotel management company to hold the required hotel license and oversee services such as centralized check-in and check-out.

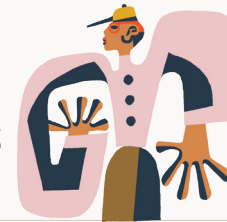
Will there be an opportunity to place my suite in a rental program?

Are there additional fees outside of the HOA?

The HOA does not charge additional fees related to renting your suite. However, owners are responsible for any third-party costs associated with renting, including fees from rental agents or property managers, as well as applicable insurance, hotel licensing, and tax requirements.

Where can I learn more about short-term rentals in Wynwood?

For a broader understanding of the rental market, we recommend speaking with a local real estate broker or trusted industry professional.

What are the rental guidelines for DUOS?

The property is located in a zoning district that allows for short-term rentals, with no minimum stay requirement and a maximum stay of 30 days.

Additional guidelines, including rental and leasing procedures, will be outlined in the Condominium Documents and are designed to ensure a well-managed and consistent experience for owners and guests.

What is the ownership structure?

DUOS is a condominium, with each suite individually owned. In accordance with zoning requirements, all suites will operate under a single hotel license.

The Association will be responsible for maintaining this license and intends to engage a hotel management company to oversee that process.
